












ENOA is SAGECare certified, a credential given to organizations that receive training to meet the needs of LGBTQIA+ older adults.



Services

CHOOSING HOME OR IN-COMMUNITY ELDER SERVICES (C.H.O.I.C.E.S.)

ENOA has three case management programs that focus on supporting older adults in maintaining their independence and supporting the efforts of family caregivers of older adults.



Care Management

Care Managers work with older individuals identifying and coordinating available community resources and services. Care Managers complete a comprehensive assessment, discuss information on resources to address assessed needs, develops a written care plan, coordinates services, resources and support and participates in ongoing monitoring of service delivery. Funding: State Funding, Client Fees.

Caregiver Support


Case Managers assist caregivers of frail, older loved ones by assessing the caregiver's strengths and needs. The result of the assessment is used to develop a support plan of respite services and resources. To qualify, caregivers must be 18 years of age or older. The care receiver must need assistance with two daily living activities or have a diagnosis of Alzheimer's disease or related disorder. Funding: Older Americans Act (OAA), ARPA, Client Contributions, Community Aging Services Act (CASA), and Medicaid Administrative Claiming (MAC).

Aged & Disabled Medicaid Waiver

Service Coordination is provided to those individuals who qualify for the Aged and Disabled Medicaid Waiver Program. Service Coordinators provide comprehensive assessments, care planning and ongoing case management. A participant-centered approach ensures the participants choices, preferences and rights are at the forefront of the services participants receive while maintaining their health, welfare and safety. Preadmission screening for long-term care is completed for Medicaid eligible individuals, age 18 years or older. Funding: Medicaid.

IN-HOME SERVICES

To receive in-home services an individual must meet Care Management eligibility guidelines. Clients are asked to contribute monthly toward the cost of the services received based on their income. Nobody is denied ENOA services due to inability to pay.



Chore Service

Lawn mowing and snow removal are provided to those homebound individuals who are receiving another ENOA service and have no one available to assist them with these chores. Funding: OAA Title IIIB, Client Contributions, CASA.

Homemaker Services

Light housekeeping service provided to those participants who are physically unable to perform those tasks. These tasks include sweeping, mopping, dusting, vacuuming, laundry, grocery shopping, etc. Funding: OAA Title IIIB, Client Contributions, CASA.

Personal Care Services


Available to individuals who are unable to safely manage personal cares. Bathing assistance, bed baths, hair washing, nail cleaning or filing, and bed linen changes may be provided. Funding: OAA Title IIIB, Client Contributions, CASA.

Material Distribution

A limited amount of durable medical equipment can be purchased for individuals who have no other way of obtaining the items. In addition, an emergency response system is available, which allows individuals to summon help in an emergency. Funding: OAA Title IIIB, Client Contributions, CASA.

NUTRITION

ENOA's nutrition programs offer healthy, nutritionally balanced meals. Meals are designed to meet one-third of the recommended dietary allowance of nutrients and comply with most current dietary guidelines for Americans.



Home Delivered Meals (Meals on Wheels)

Hot, nutritious meals are delivered weekdays to homebound older adults who are unable to prepare a meal for themselves or have no one available to do so. Recipients are certified for the meal delivery by either an ENOA care manager or the program's intake specialist. Funding: OAA Title III C2, Social Services Block Grant for Aged and Disabled (SSBG), Client Contributions, CASA, Nutritional Services Incentive Program (NSIP).

Senior Centers

Senior centers serve as resource centers in neighborhoods and rural communities. Meals are provided to older adults in a group setting. Each center hosts a variety of recreational and social activities, guest speakers, crafts, nutrition and health programs. ENOA directly runs seven senior centers and contracts with twelve others in the five county area served by ENOA. Funding: SSAD, Client Contributions, CASA, OAA Title IIIC1, OAA Title IIID.

Diner's Choice

Diner's Choice provides a flexible meal schedule for busy individuals who are 60 years of age or older. This program is currently offered at all Hy-Vee stores in the Omaha, Papillion, Fremont & Plattsmouth areas. Pre-enrollment is required. Funding: ARPA, OAA.

COMMUNITY SERVICES

Information & Assistance

Information and Assistance (I&A)

ENOA's Information & Assistance phone line serves as a gateway for caregivers, potential clients, providers, friends and family members seeking information about programs and services for older adults. Staff answer questions about aging services and, if appropriate, complete a referral for ENOA's in-home services, or, refer the caller to resources within the community. The I&A Division also provides speaking engagements within the community. Funding: OAA Title IIIB.

ADRC

Aging & Disability Resource Center (ADRC)

The ADRC provides information, assistance, and education in community services and long-term care options for individuals over age sixty, persons with disabilities of any age, or family members, caregivers, advocates and providers for these groups. ADRC Options Counselors are available over the phone or through face-to-face meetings at the main office by appointment. Funding: Aged & Disabled Resource Center (ADRC), local funds.

New Horizons

New Horizon/Public Affairs

The New Horizons is one of the longest running newspapers devoted to older adults. The paper began in 1975 and presents a realistic portrait of aging in our society. The current monthly circulation of 8,000 newspapers is distributed through direct mail. In addition to the paper, the Public Affairs Division promotes and publicizes ENOA's programs and activities and maintains an active social media presence. Funding: OAA Title IIIB.

Legal Services Resources

Legal Service Resource

ENOA contracts with Legal Aid of Nebraska to provide the ElderAccess Line, which provides older individuals with economic or social needs legal advice and limited representation by an attorney, paralegal or law student under the direct supervision of an attorney. In addition, the State Unit on Aging introduced a legal risk screening tool – Legal Risk Assessment - in 2023. Funding: OAA Title IIIB.

Intergeneration Orchestra (IGO)

Intergeneration Orchestra of Omaha (IGO)

The Intergeneration Orchestra of Omaha was formed in 1985 and has continued to play venues all over Omaha ever since. Musicians, age 50 and older or age 25 and younger make up the orchestra. Funding is entirely through grants, donations, memberships, fundraisers and performance fees. ENOA contributes in-kind services to assist with the administration of the group. Funding: Membership drive, tuition, donations, endowment fund.

VOLUNTEER PROGRAMS

Each year over 400 individuals contribute their time, skills, and compassion to better their community as an ENOA volunteer.

AmeriCorps Seniors: Foster Grandparent Program

Volunteers work with children needing special attention to improve their academic, social or emotional development. Funding: Americorps Seniors, local.



AmeriCorps Seniors: Senior Companion Program

Volunteers provide supportive, individualized services to help older adults with special needs maintain their dignity and independence. Funding: Americorps Seniors, local.



SeniorHelp

Persons of any age volunteer with older adults, sharing their time in ways that will help the older adult remain independent, in their own home, and improve the quality of their life. Funding: CASA.



Ombudsman

Ombudsman volunteers are trained volunteers who advocate for the rights and well-being of nursing home and assisted living facility residents. Funding: OAA Title VII, MAC.




Volunteer Connect
